New employees are assigned a Healthstream online educational course, "Diversity, Equity, and Inclusion." Additionally, on an annual basis, all employees are to complete a mandatory Healthstream online educational course, "Cultural Competence & Diversity." This course is based on our patient populations and the culturally diverse patients staff may encounter.

Directional signage is currently available only in English and Braille; it would be helpful to add Spanish for patients and visitors and also have maps of the campus in Spanish.
